

LETTER from the PRESIDENT and CHAIRMAN

A Rational Exuberance

"What does CLIR do?" A succinct question, a typical formulation asked by those who encounter CLIR's name or logo on one of our programs, publications, or websites. There are many ways to respond; an equally succinct reply is that CLIR's research, institutes, fellowships, and sponsored projects bring coherence to the often disruptive and always complex milieu of higher education. CLIR's contributions help make this environment better organized and understood, more manageable and, not the least, more interesting.

CLIR's focus on higher education builds on decades of leadership provided for academic libraries. One term that characterizes the early years of the twenty-first century is *boundary event*. Drawn from geology, a boundary event is an often traumatic, decisive period in which a major ecological shift occurs, usually involving some degree of extinction and the emergence of different life forms in a significantly altered climate. Our contemporary analog/digital boundary event is virtual and empirical, but it is nonetheless real: it will likely favor a breathtaking florescence of digital resources and applications along with a decisive waning of analog communication.

CLIR's research, programs, projects, and other methods of engaging our constituency reflect our convictions that the future of higher education will not consist of a digitized printed book, or a research library reconstituted as an electronic database, or a classroom skyped. For scholarship and its communication, the digital environment almost insists on new intellectual strategies, new methodologies for research and discovery, and new pathways for preservation and access. With ease, digital technologies disaggregate, reform, and reuse information, allowing for multivalent forms of scholarship that cannot fit in a book or printed journal. It allows the "distant reading" of thousands of texts or images across centuries, linked to often vast research data, all the while creating more porous, loosely bounded formats of intellectual expression while engaging wider

communities in the research process. It is not just information that is roiled and reconstituted. Our traditional methods and procedures for self-valuation and promotion, whether as a lone scholar, a team, a department, a library, or a university, must be rethought.

Given the scope and complexity of rethinking so many aspects of higher education, one of the most important contributions CLIR can make is to create a trusted structure in which administrators and other leaders can meet and develop strategies that more rigorously manage the transition from analog to digital: a virtual space wherein the boundary event can evolve programmatically, concertedly, and efficiently. The Committee on Coherence at Scale has been created to help assure the coherent development of the various parts of the emerging digital environment in such a way that benefits higher education—in a way that improves scholarly productivity and teaching, and that is cost effective and sustainable.

Executing an eventual strategy will be a national effort requiring sophisticated collaboration and coordinated activity, adopting a systems approach for which we are poorly trained. To this end, CLIR will inculcate partnerships with selected institutions that can provide leadership and appropriate infrastructure for the intertwined facets of knowledge organization and scholarly communication. CLIR will continue to exercise leadership, taking advantage of our connections and pool of expertise. For the design and development of this new environment, CLIR will additionally provide continuity, consistency, and management.

CLIR's work can be characterized by an analogy to constellations: ordering the night skies by aligning the stars into coherent patterns. Seemingly random points of light become an array of easily recognized and culturally shared images. Individually a constellation can invoke a mythological narrative, a poignant story of the origins of a terrestrial phenomenon that can also convey insight into the human condition. Collectively they provide, and have for millennia, an elegant map for navigating the uncharted forays of body and mind in pursuit of new discovery.

PROGRAMS and ACTIVITIES July 1, 2012-June 30, 2013

DIGITAL INFRASTRUCTURE

Objective: Define the base technologies of computation and communication, the software programs, and the data curation and preservation programs that are national in scale and necessary to manage very large-scale multimedia data sets, especially those pertaining to the digital record of our cultural heritage.

Digital Library Federation Program

CLIR's Digital Library Federation (DLF) program focuses on the technological aspects of developing, sustaining, and aggregating digital resources; promoting standards, protocols, and best practices; and supporting digital architectures that are open source, extensible, and interoperable. The DLF program is integral to all of CLIR's work, from activities in data curation and leadership to service on the Committee on Coherence at Scale for Higher Education, formed in October 2012.

The DLF Forum is convened annually and includes digital library practitioners from member institutions and the broader community. It serves as a venue for the exchange of information that will lead to a better understanding of the elements and complexity of digital library evolution, as well as for collaboration on practical work. The 2012 Fall Forum was held November 4-5 in Denver, Colorado. CLIR Board member Kathleen

> Fitzpatrick, director of scholarly communication at the Modern Language Association, presented the keynote, "Planned Obsolescence Publishing Technology and the Future of the Academy."

Development of Data Curation Skills

There is an urgent need for a reliable and increasingly sophisticated professional cohort to support data-intensive research in our colleges, universities, and research centers. Data curation activities enable data discovery and retrieval, maintain its quality, add value, and provide for reuse over time. This new field includes authentication, archiving, management, preservation, retrieval, and representation.

In an effort to raise awareness and build capacity for sound data management practices throughout the academy, CLIR launched the CLIR/DLF Data Curation Fellowship Program in the spring of 2012 with support from the Alfred P. Sloan Foundation. The program provides recent Ph.D.s with professional development, education, and training opportunities in data curation for the sciences and social sciences. Later that year, with support from The Andrew W. Mellon Foundation, CLIR expanded the program to include Data Curation Fellowships in Medieval Studies.

Committee on Coherence at Scale for Higher Education

In October 2012, CLIR and Vanderbilt University established a committee to examine emerging national-scale digital projects and their potential to help transform higher education in terms of scholarly productivity, teaching, cost-efficiency, and sustainability.

The group, called the Committee on Coherence at Scale for Higher Education, comprises college and university presidents and provosts, deans, university librarians, and association heads. The **committee** will focus on research and analysis of the large projects and their correlation; initial costs, operating costs, and business plans for sustainability; and benefits and transformational aspects. Examples of these projects include the Hathi Trust, the Digital Public Library of America, the Digital Preservation Network, and data curation centers. Results of the committee's work will be publicized regularly.

ARL/DLF/DuraSpace E-Science Institute

DLF continued to sponsor the E-Science Institute, which completed its second year in spring 2013 with the additional sponsorship of DuraSpace. The E-Science Institute is designed to help academic and research libraries develop strategies for supporting computational scientific research. The coursework begins with a series of exercises for teams to complete at their institutions, and culminates with an in-person workshop. Local institution assignments help staff establish a high-level understanding of research support needs and issues.

Digital Public Library of America

DLF Director Rachel Frick continued to co-chair the Digital Public Library of America (DPLA) Content & Scope Workstream, and workshops were held in August 2012 and February 2013. Much of the work focused on the DPLAtform: a set of services to gather metadata about content and collections made accessible through the DPLA, and to enable developers to use

the metadata to build new applications and integrate the metadata into existing sites and services.

The Content & Scope Workstream focused initially on what is readily available: collections that are already digitized, in the public domain, and free of copyright restrictions. The first step was to collect the metadata representing digital objects in these collections.

In April 2013, DPLA launched its discovery portal and open platform. The website, at **dp.la**, links the public with millions of items from the collections of libraries, museums, and cultural heritage institutions. Just prior to launch, DPLA announced the formation of a new committee structure. CLIR President Chuck Henry was appointed to the advisory committee, and DLF Program Director Rachel Frick was appointed co-chair (with Emily Gore) of the Content Strategy Committee, on which CLIR Program Officer Jena Winberry also serves.

Fit For Purpose

DLF sponsored research and publication of *Fit for Purpose*: *Developing Business Cases for New Services in Research Libraries*. Published by MediaCommons Press in October 2012, *Fit for Purpose* provides a decision-making toolbox created from elements of social entrepreneurship and project

management that are consistent with research library environments and values. It addresses organizational readiness and risk tolerance, business case development, piloting new services, and monitoring sustainability through the business planning lifecycle. The report presents a set of recommendations that libraries can adopt when developing any new service. Fit for Purpose was developed by a team that includes Mike Furlough, of Penn State University; Ted Fons, of OCLC; Elizabeth Kirk, of Dartmouth College; Michele Reid, of North Dakota State University; and Carol Hunter, of the University of North Carolina. Judy Luther, president of Informed Strategies, served as an advisor to the project.



SCHOLARSHIP and RESEARCH

Objective: Explore and assess new research methodologies, emerging fields of inquiry, intellectual strategies involving data gathering and collaboration, and modes of communication, including sharing of research data and publishing models, that are likely to define the next generation of scholars.

Postdoctoral Fellowship Program

CLIR Postdoctoral Library Fellows work on projects that forge, renovate, and strengthen connections between academic library collections and their users. The program offers scholars who have recently earned their Ph.D.s a chance to work in academic libraries on projects that are related to their disciplines and, thus, benefit both the scholar and the library. The fellows have the opportunity to develop research tools, resources, and services while exploring new career opportunities. Participating libraries benefit from the expertise of accomplished scholars who offer insights into the collections' potential uses and users, scholarly information behaviors, and current teaching and learning practices within particular disciplines.

In spring 2012, CLIR expanded the Postdoctoral Fellowship Program in Academic Libraries by adding a new component: the CLIR/DLF Data Curation Fellowships for the Sciences and Social Sciences. Later that year, CLIR introduced the CLIR/DLF Data Curation Fellowships for Medieval Studies. The Data Curation Fellowships provide scholars who have recently earned their Ph.D.s with professional development, education, and training opportunities in data curation for the sciences and social sciences.

The program had 30 new and continuing fellows in the 2012–2013 academic year (see p.18).

Cataloging Hidden Special Collections and Archives

CLIR's Cataloging Hidden Special Collections and Archives Program supports efforts to expose unknown or underutilized cultural materials to communities of scholars, students, and other users who need them for their work. Twenty-two projects were selected to receive a total of \$3.7 million in awards for the 2012 funding cycle. In early 2013, CLIR announced that Canadian institutions would be eligible to partner with US-led collaborative projects applying for Hidden Collections awards.

Since 2008 when the program was initiated, 83 projects, representing a wide range of institutions across the United States, have been funded. The projects have already made large volumes of cultural materials in diverse formats accessible to scholars.

In late June 2012, CLIR launched its **Registry of Hidden Special Collections and Archives**, a web-based browsable registry of hidden materials

compiled from data submitted by grant applicants. The registry's records reflect great diversity in collection holdings. Not only are hidden books, images, manuscripts, and artworks nominated for cataloging, but increasing numbers of audio and audiovisual formats, maps, architectural drawings, artifacts, and items of ephemera are also brought to the attention of reviewers each year. The registry enables searching by subject, keyword, format, institution type, and year added to registry. It is hoped that increased awareness of these materials will help cultural heritage institutions attract partners, volunteers, or funding to support better preservation of their collections, and that scholars and their students will use the registry to find previously unused and underused materials and promising new avenues for research.

Work continues on a multiyear study to describe successful strategies for engaging users with collections. The study, entitled "Observations on

The Andrew W. Mellon Foundation provides funding for the Cataloging Hidden Special Collections and Archives Program.

Mellon Dissertation Fellowships

The Mellon Dissertation Fellowship Program helps junior scholars in the humanities and related social science fields gain skill and creativity in developing knowledge from original sources; enables dissertation writers to do research wherever relevant sources may be, rather than just where financial support is available; encourages more extensive and innovative uses of original sources in libraries, archives, museums, historical societies, and related repositories in the United States and abroad; and provides insight from the viewpoint of doctoral candidates into the effective development of scholarly resources for access in the future.

The fellowship program, initiated in 2002, has supported 179 graduate students as they carried out their dissertation research in a variety of public and private libraries and archives.

Workshops on Participatory Design in Academic Libraries

Led by Nancy Fried Foster, director of anthropological research at the University of Rochester's River Campus Libraries, the workshops on participatory design in academic libraries have provided attendees with an overview of the participatory design process and strategies for including

faculty members, graduate students, undergraduates, and library staff in the design process. The workshops have featured extensive interaction among participants, as well as between participants and research subjects. The first workshop was held in 2007, and the final workshop took place in April 2013. More than 250 people participated in the workshops over the program's six years.

In June 2013, the second CLIR Seminar on Issues of Participatory Design in Academic Libraries was held at the University of Rochester. The seminar was an opportunity for participants of previous CLIR participatory design workshops to present projects that they have conducted using the techniques they learned from Foster. A report on the seminar will be published early in 2014.

Anvil Academic Publishing

In February 2012, CLIR and the National Institute for Technology in Liberal Education (NITLE) joined forces with a group of colleges and universities to establish Anvil Academic, a digital publisher for the humanities. Anvil Academic focuses on publishing new forms of scholarship that cannot be adequately conveyed in the traditional monograph and serves as a testbed for alternate business models for scholarly publishing.

In the months following its launch, Anvil created its own website (www. anvilacademic.org) and in November 2012 announced its "Built Upon" initiative, whose goal is to produce scholarship and educational resources using existing digital tools, archives, and collections.

Anvil Academic Publishing received startup funding from the Brown Foundation, Inc. In addition, Stanford University, Washington University in St. Louis, Bryn Mawr College, Amherst College, Middlebury College, Southwestern University, and NINES provide funds and staffing.

PRESERVATION and ACCESS

Objective: Examine sustainable strategies for preserving all media, analog and traditional, and heighten public awareness of the risks of failing to plan for preservation.

Preserving Recorded Sound Heritage

Since 2004, CLIR has conducted work under contract with the Library of Congress and the National Recording Preservation Board in support of an ongoing study of the state of recorded sound preservation and restoration. In December 2012, CLIR published the *Library of Congress National Recording Preservation Plan*. The congressionally mandated plan spells out 32 short- and long-term recommendations involving both the public and

private sectors and covering infrastructure, preservation, access, education, and policy strategies.

In the spring and summer of 2013, CLIR staff undertook editing and layout work on *The Survival of American Silent Feature Films*: 1912-1929, published in September 2013. The report, by David Pierce, is the first comprehensive survey of American feature films that survived the silent era of motion pictures.

LEADERSHIP EDUCATION and CULTIVATION

Objective: Investigate and seek to define the skills and expertise needed to administer, inspire, and inform the next generation.

Leading Change Institute

Forty librarians and information technologists attended the first Leading Change Institute June 2–7, 2013, in Washington, DC. CLIR and EDU-CAUSE sponsor the Leading Change Institute, which is successor to the Frye Leadership Institute.

The Institute is intended for leaders who seek to further develop their skills for the benefit of higher education. New sources of competition, use of technology to support effective teaching and learning, distance learning, and changing modes of scholarly communications are among the developments that call for new qualities for leadership in higher education today. These issues inform the Leading Change Institute's scope. Participants discuss approaches to addressing these issues, including ideas for collaboration, collective creativity, and innovation within and across

Accordingly, we express no such opinion. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Opinion

In our opinion, the financial statements referred to above present fairly, in all material respects, the financial position of the Council on Library and Information Resources as of June 30, 2013, and the change in its net assets and its cash flows for the year then ended in accordance with accounting principles generally accepted in the United States of America.

Other Matter

Our audit was conducted for the purpose of forming an opinion on the financial statements as a whole. The schedule of functional expenses on page 38 is presented for purposes of additional analysis and is not a required part of the financial statements. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. In our opinion, the information is fairly started in all material respects in relation to the financial statements as a whole.

NOTES TO FINANCIAL STATEMENTS

June 30, 2013

NOTE 1- Organization

The Council on Library and Information Resources is a not-for-profit organization incorporated under the laws of the District of Columbia in 1988 for the purpose of fostering, developing, and supporting systematic and purposeful collaboration in order to ensure the preservation of the published and documentary record in all formats and provide equitable access to that information.

The Council on Library and Information Resources operations are financed through contributions from colleges, universities and other organizations and through general support grants and restricted grants from private foundations and other sources. The Council on Library and Information Resources conducts its work directly through committees and working groups as well as through contracts with other organizations and individuals.

NOTE 2- Summary of Significant Accounting Policies

<u>Basis of accounting</u> - The accompanying financial statements of the Council on Library and Information Resources have been prepared on the accrual basis.

Grant revenue and recognition of grantor restrictions - The Council on Library and Information Resources reports grants as temporarily restricted support if they are received with grantor stipulations that limit the use of the grants as to time or purpose. When either condition is satisfied, temporarily restricted net assets are reclassified to unrestricted net assets and reported in the statement of activities and changes in net assets as net assets released from restrictions. Support that is restricted by the grantor is reported as an increase in unrestricted net assets if the restriction expires in the reporting period in which the support is recognized.

<u>Contracts / Grants payable</u> - Contracts made by the Council on Library and Information Resources are recorded as contracts payable and expensed at the time contracts are awarded. Current period expenses are adjusted for contract refunds or over appropriations when received.

<u>Board designated net assets</u> - From time to time, the Board of Directors designates a portion of unrestricted net assets for various short-term projects.

<u>Cash and cash equivalents</u> - For purposes of the statement of cash flows, cash and cash equivalents consist primarily of deposits in a money market account and investments with original maturities of 90 days or less.

<u>Advertising costs</u> – Advertising costs are expensed as incurred.

NOTES TO FINANCIAL STATEMENTS

June 30, 2013 (Continued)

NOTE 2- Summary of Significant Accounting Policies (continued)

<u>Accounts Receivable</u> - Accounts receivable represent grant receivable, and current unreimbursed expenses on various contracts. Allowance for doubtful accounts is normally recorded for amounts deemed as uncollectible. The Council on Library and Information Resources management has evaluated accounts receivable collection from prior years and has determined that an allowance for doubtful accounts is not necessary.

<u>Functional allocation of expenses</u> - Costs of the various programs have been summarized on a functional basis in the accompanying financial statements. Salaries and travel costs have been allocated directly to programs and administration on a time-allocated basis.

<u>Furniture and Equipment</u> - Furniture and equipment are recorded at cost, less accumulated depreciation. Depreciation expense is computed using the straight-line method over the estimated useful lives of the respective assets. Expenditures for maintenance and repairs are charged against income as incurred; betterments which increase the value or materially extend the life of the related assets are capitalized.

<u>Contributions</u> - The Council on Library and Information Resources records grant income as unrestricted, temporarily restricted, or permanently restricted support, depending upon the terms and conditions of the grant.

<u>Fair value of financial instruments</u> – Management estimates that the fair value of all financial instruments at June 30, 2013 does not differ materially from the aggregate carrying values reported in the accompanying statement of financial position due to the short term maturities of those instruments.

<u>Use of estimates</u> - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

<u>Subsequent Events-</u> In preparing these financial statements, The Council on Library and Information Resources has evaluated events and transactions for potential recognition or disclosure through the date the financial statements were issued

NOTE 4- Investments

The Council on Library and Information Resources has adopted SFAS No. 124, "Accounting for Certain Investments Held by Not-for-Profit Organizations." Under SFAS No. 124, investments in marketable securities with readily determinable fair values and all investments in debt securities are reported at their fair values in the statement of financial position. Unrealized gains and losses are included in the change in net assets. Investment income and gains restricted by a donor are reported as increases in unrestricted net assets if the restrictions are met (either by passage of time or by use) in the reporting period in which the income and gains are recognized.

NOTE 5 - Income Taxes

The Council on Library and Information Resources is exempt from federal income taxes under Section 501(c)(3) of the Internal Revenue Code and applicable regulations of the District of Columbia.

NOTES TO FINANCIAL STATEMENTS

June 30, 2013 (Continued)

NOTE 5 - Income Taxes (Continued)

The Organization is subject to income taxes in U.S. federal jurisdictions and various state jurisdictions. Tax regulations within each jurisdiction are subject to the interpretation of the related tax laws and regulations and require significant judgment to apply. In accordance with authoritative guidance on accounting for uncertainty in income taxes issued by the Financial Accounting Standards Board (the FASB), the Organization recognizes tax liabilities for uncertain tax positions when it is more likely than not that a tax position will not be sustained upon examination and settlement with various taxing authorities. Liabilities for uncertain tax positions are measured based upon the largest amount of benefit that is greater than 50% likely of being realized upon settlement. The guidance on accounting for uncertainty in income taxes also addresses de-recognition, classification, interest and penalties on income taxes, and accounting in interim periods. Management has evaluated the Organization's tax positions and has concluded that the Organization has no uncertain tax positions that require adjustment to the financial statements to comply with the provisions of this guidance. Income taxes are accounted for under the asset and liability method. Management believes it is no longer subject to income tax examinations for years prior to June 30, 2010.

NOTE 6 - Net Assets released from Restrictions

Net assets were released from grantor restrictions by incurring expenses satisfying the restricted purposes or by occurrence of other events specified by grantors.

NOTE 7 - Retirement Plan

Employees are eligible for participation in the Council on Library and Information Resources defined contribution retirement annuity program ("the Plan") administered through the TIAA/CREF insurance companies. Individual contracts issued under the Plan provide for full and immediate vesting of the Council on Library and Information Resources contributions. The Council on Library and Information Resources contributes 15% of employees' salaries to the Plan each year. The Council on Library and Information Resources contributions were \$140,582 in 2013.

NOTE 8 - Concentrations of Credit Risk

Financial instruments which potentially subject the Council on Library and Information Resources to concentrations of credit risk consist primarily of cash equivalents. At June 30, 2013, the Council on Library and Information Resources held \$1,951,524 in investments. This amount is not insured by the Federal Deposit Insurance Corporation. In addition, cash in bank and investment accounts are insured under FDIC up to \$250,000 for each bank. At June 30, 2013, the uninsured cash balance was \$6,664,794

The Council on Library and Information Resources received \$4,300,000, \$1,550,000, and \$896,000 for three grant programs which represents 48 %, 17%, and 10% of total revenue respectively.

NOTE 10 - Commitments

The Council on Library and Information Resources has entered into two noncancelable operating lease agreement for its office space which expires in August , 2018 and April , 2019 . The Council on Library and Information Resources has entered into a sublease with another organization that it collects rent from which expires August , 2018. Rental expense, for the year ending June 30, 2013 was \$154,919. The Council on Library and Information Resources is also leasing a copier under a capital lease. This lease will expire in January 2015.
